| Drug Testing Rules Refer to updated rules book and update accordingly | Section 2: DRUGS AND FORBIDDEN SUBSTANCES a) The exhibitor or his agent is to advise the Horse Show Manager or Secretary in writing of all drugs administered in any fashion within seventytwo (72) hours prior to or during the show. This information is to be made available for inspection by anyone interested. No horse shall be eligible for competition in any class if it has been administered a forbidden substance, i.e. any stimulant, depressant, tranquillizer or local anesthetic which might affect the performance, temperament or courage of the horse. Also prohibited are any drugs which might mask or screen the presence of forbidden substances. Any horse entered in an approved show is subject to examination by the official Show Veterinarian. Refusal to submit a horse for examination and to cooperate with the discretion of the veterinarian. Refusal to submit a horse for examination and to cooperate with the official Show Veterinarian and technicians constitutes a violation and subjects the responsible person to penalties. There will be ZERO tolerance. Mandatory testing fee per horse on entry form: a drug testing fee of \$10.00 per horse for any PHAC approved show held in Canada. Shows will remit the total of fees to the secretary or treasurer of the PHAC and fees for drug testing will be paid by the PHAC. It will be the responsibility of the drug testing committee to arrange for the drug testing at shows they deem should be drug tested. The drug testing shall take place on the last day of the show as late as possible in the day, preferably subsequent to the Barrida of Champions. A drug testing committee or coordinator shall be appointed each year by the PHAC Board of Directors. They shall be responsible for: a) Choosing the shows to be drug tested for the year. b) Picking which classes and placings in those classes that are to be drug tested. c) Sending a sealed envelope to the Show Steward for that particular show, outlining the chosen classes |

| Confirm Vet and Show Steward have Received the Letters | 1. Contact the Vet and the Show Steward prior to the show to make sure they received the letters In the event the letters have not been received or misplaced a copy can be emailed to the Vet and Show Steward no earlier than noon the last day of the show (make arrangements with the Vet and Show Steward to ensure they are able to receive emails on a secured device (smart phone) In the event that the Vet and/or Show Steward are unable to receive email a verbal conversation can take place once the Vet has arrived on the show grounds (make sure you have access to the letters you sent to ensure the instructions and selections are accurate) |
| No Drug Testing | Drug testing is done at the discretion of the Drug Testing Committee, with the exception of the Nationals. If you decide drug testing will not be done for a Regional Show then follow the same notification process and send the letters to the Show Steward Do not order the kits (since the kits go directly to the Vet to maintain chain of custody, there should be no indication to the Show Staff that there will be no testing until the letter is opened Refer to Attachment 3 |

Frequently Asked Questions (FAQ)

1. Can the instructions be sent via email if they did not arrive as expected, or get mistakenly forgotten? If so, should they be emailed to the Veterinary or to a Show Official?

Answer: In the event of a problem, the instructions may be emailed to the veterinary no earlier than noon on the last day of the show.

2. What happens if the vet is unable to get to the arena on time (delayed by an emergency)?

Answer: All horses that are scheduled to be drug tested should remain on the show grounds until they are tested or 1 hr after the show has finished whichever comes first. If the vet is still not able to get to the arena by 1 hr after the show has finished, the drug testing shall be automatically cancelled.

3. Can the Drug Testing Committee 'designate' a Show Official to authorize the cancellation of the testing for unforeseen circumstance?

Answer: Only the Chair of the Drug Testing Committee can cancel the testing.

4. What happens if the instructions indicate to test the winning horse of a class and that horse was also the winning horse of another class that was selected? Does one blood sample collection suffice?

Answer: One blood sample collection would suffice.

5. What happens if the horse that was selected (any class / random testing) does not remain on the grounds until the end of the show? How & when does the test get done?

Answer: The horse would forfeit all placings and points earned at the show.

6. What happens with unused Drug Kits?

Answer: Unused drug kits may be given to the Show Steward to be returned to Maxxam. (I need to see if they can be returned to Maxxam for a credit towards a future order).

As stated below, the rules require the draws to be taken as late as possible on the last day of the show. The enclosed sealed envelope should not be opened until you arrive on the Show Grounds and are with the Show Steward. Once the collections are done please return the specimens and the container to Maxxam. As noted in the enclosed letter, Maxxam does not want the name of the horse added to any of their documentation – they only use their reference number for processing results.

The Show Veterinary will be reimbursed for shipping expenses, please have them submit courier bills along with their invoice for services directly to the Peruvian Horse Association of Canada.

Section 2: DRUGS AND FORBIDDEN SUBSTANCES

a) The exhibitor or his agent is to advise the Horse Show Manager or Secretary in writing of all drugs administered in any fashion within seventytwo (72) hours prior to or during the show. This information is to be made available for inspection by anyone interested.

No horse shall be eligible for competition in any class if it has been administered a forbidden substance, i.e. any stimulant, depressant, tranquillizer or local anesthetic which might affect the performance, temperament or courage of the horse. Also prohibited are any drugs which might mask or screen the presence of forbidden substances. Any horse entered in an approved show is subject to examination by the official Show Veterinarian. Such examinations may include physical, saliva, urine and blood tests at the discretion of the veterinarian. Refusal to submit a horse for examination and to cooperate with the official Show Veterinarian and technicians constitutes a violation and subjects the responsible person to penalties. There will be ZERO tolerance. Mandatory testing fee per horse on entry form: a drug testing fee of \$10.00 per horse for any PHAC approved show held in Canada. Shows will remit the total of fees to the secretary or treasurer of the PHAC and fees for drug testing at shows they deem should be drug tested. The drug testing shall take place on the last day of the show as late as possible in the day, preferably subsequent to the Barrida of Champions.
